The Committee reviewed the minutes of the meeting held on 9th April 2025 and resolved to accept them as a true record.

In relation to the Minutes, Cllr Veck informed the Committee that he would circulate an amended version of the Highway Improvement Plan at the Full Council meeting to be held in June.

PHE/25/35 Public Participation Session

A resident enquired about the proposed tree pruning at St Peter's Presbytery, expressing concerns about the extent of tree trimming and seeking clarification on the timing, monitoring, and potential impact of the proposed work. Cllr Veck outlined the details of the tree pruning application, noting the proposed five-meter clearance for vehicles and the specific locations of the trees.

The resident also enquired about the Neighbourhood Plan, questioning the committee's readiness to manage potential Westgate development. They emphasized the need for an active working party, proactive preparation, and protection of the town's heritage and infrastructure against potential large-scale development.
