### Planning Decisions by Thanet District Council as follows: -

FH/TH/23/1573: Erection of 1 No. rear dormer, 1 No. conservation style roof light to the front elevation and 1No. to the side elevation of the roof to facilitate loft conversion, together with the reduction in depth of existing garage, to increase the depth of the front drive: 30 Cuthbert Road Westgate on-Sea CT8 8NR. **Outcome: Permission granted**.

F/TH/23/1687: Proposal Installation of replacement windows and doors from timber to UPV: Marine Heights 53 Beach Road Westgate on-Sea CT8 8AD. **Awaiting decision.**

#### Support

TCA/TH/24/0113: 5 No Cherry (T1, T2, T3, T4, T5) 1.5m tip reduction, 1No Cherry (T7) - 2.5m tip reduction, 1No Cherry (T8) - 3m tip reduction, 1No Cherry (T10) - 3m tip reduction: The Boulevard, Westgate-on-Sea CT8 8EP. Comment: *Decision pending. Matter delegated to Committee to investigate and report back on findings. Westgate-on-Sea Town Council's support is subject to no negatives being found. Outcome: Support.* 

FH/TH/23/1668: Erection of a two-storey side extension following demolition of existing shed: 2 Tidewell Mews Westgate-on-Sea CT8 8PX. *Comment: Due to new information being received which was not available before, Westgate-on-Sea Town Council's current position is to support the proposal subject to adequate parking provision being in place to serve a property of that size ((Proposer: Cllr. Wallin, secondary Cllr. Donaldson and carried.)* 

#### Object

F/TH/24/0079: Application for variation of condition 9 of planning permission F/TH/05/1458 for the "Erection of single storey rear extension to ground floor flat with alterations to internal layout of ground and basement flats to create two additional flats" to allow parking for non-residents: 20 - 21 Roxburgh Road, Westgate-on-Sea CT8 9RX. *Comment: Westgate-on-Sea Town Council objects to the introduction of parking for non-residents on this site due to the detrimental impact this will have on existing residents' amenities. (Proposer: Cllr. Wallin, secondary Cllr. Donaldson and carried.)* 

### Neutral

F/TH/23/1677: Erection of 4 No commercial units for use as artist studios together with cycle store/bin store and storage unit: Westgate-on-Sea Investments, Units 1 - 4, Elm Grove, Westgate-on-Sea. Comment: Westgate-on-Sea Town Council could not make an informed decision on this proposal due to insufficient information being available on the planning portal. The Town Council would like to see what the other statutory consultees are saying alongside the Public's view to get a full picture of the matter. ((Proposer: Cllr. Wallin, secondary Cllr. Donaldson and carried.)
